# WORLD WAR II -- George Richard Elderkin By Deborah Gammon

The Elderkin family buried in Fairview Cemetery began in Pennsylvania. Frank W. Elderkin, the son of Dennison and Amanda Williams Elderkin was living in Crawford County, Pa. on the 1910 U. S. Federal Census. Frank was wed to Lois Frances Depew 14, October 1905 in Westfield, New York. He and Lois already had 4 children by the 1910 census. The family then moved to Texas. They were living in Hardin County on the 1920 census with 8 children.

One of those children was George Richard Elderkin who was born in Port Arthur, Texas on 17 February, 1914. George died tragically 1 March 1945 at No.7, RAF Hospital in Aden, Arabia. His remains were originally buried in Plot #52 of the Maalla cemetery in Arabia, which is now Yemen. Maala lies on the Southern side of Aden Harbor. His remains were later moved to El Alia Cemetery in a suburb of Algiers in the commune of Oued Smar in Algeria. How did he get in Arabia? And how did he get home to Fairview? The U.S. Federal Census of 1930 has the family of Frank W. Elderkin with 16 year old George living in Precinct #6 (League City) of Galveston County. Sixteen-year old George is a dock hand.

By 1936 George was a seaman aboard the SS Lamont DuPont. He applied for an application for Seaman's Protection Certificate on October 21 of that year. An American Seaman would carry such document as proof of citizenship. It was obtained through a customhouse or a U. S. Consul. This document is the only document that gives us a picture of the young man. He stood 6', weighed 150 pounds with brown hair and eyes. Somewhere along the way, George was married to a woman named Wilma. One report listed his education as grammar school. The report that listed his education as grammar school was the U. S. WWII Army Enlistment Records, 1938-1946. George enlisted 31 Mar 1941 in New York City. He had been a cook.

George was discharged on 1 March 1945, his death date. Merchant Mariners have supported the military since the beginning but were not eligible for military benefits until Congress passed two laws in 1977 and 1988. Luckily, George had enlisted in the Army allowing his mother to apply for him to get a marker. After his death the consul in Arabia wrote to Mrs. Wilma Elderkin in Brooklyn, NY. She had already remarried and told Harlan B. Clark, the consul, that his family had lived "somewhere in Texas". Continued on next page)




I originally got my information on George in 2008 when I was doing research for the "Ghosts of the Past" cemetery tour. I had to write the Department of the Army for George's Individual Deceased Personnel File using the Freedom of Information Act. I received many documents about George and his death. Twelve years later to write this column, I plugged George's name in ancestry.com. His entire military record including the gut-wrenching hospital stay and death that George endured is now online. I will avoid printing or saying much about his death because of the sensitive nature of it. George entered the R.A.F.#7 Hospital on 22 February 1945 from his Ship, the SS Joseph S. Emery, owned by Sears Shipping Co., Inc., New York, New York. He is listed as Chief Steward. I had to look that up, too. A Chief Steward is defined as the person who directs, instructs and assigns personnel to perform such functions as preparing and serving meals, ensuring that they are both delicious & nutritious. The original notes on his hospital record say that he was "disorientated for time & space." He worsened over time and passed away on 1 March 1945 from toxic

nephritis. And Now for the good news:

"The people of the United States, through Congress authorized the disinterment and final burial of the heroic dead of World War II" began the letter of 22 Sep 1947 addressed to Mrs. Lois Elderkin, George's mother. She chose to have George returned home. His original interment report showed that he was buried in a blanket and was given a wooden cross. His remains were disinterred on 15 Nov 1948. His remains were prepared and placed in a casket and readied for the trip back to Texas. (continued on next page)

\*Richard Thomson died at Pearl Harbor and returned to Fairview June of 2019.

\*George R. Elderkin died in hospital during WWII and returned in 1949.

George along with the other WWII soldiers and sailors will be honored at Wreaths Across America on 19 December 2020.

#### Merchant Seaman Rites To Be in League City

Marf Special to The News ALVIN, March 7.-The body of Merchant Seaman George R. Elderkin, 31, of League City, will arrive here Tueseday at 8 a. m.

Mr. Elderkin, who died March 1, 1945, in a RAF hospital at Aden, Arabia, was a member of the United States army before transfer to the merchant marine.

He was born Feb. 17, 1914, in Port Arthur.

He is survived by his parents, Mr. and Mrs. F. W. Elderkin of League City; three brothers, J. D. of McPherson, Kan.; Frank of Galveston and Jack of Freeport; three sisters, Mrs. H. C. Rowland of Mc-Pherson, Mrs. Dona Kay of League City and Mrs. E. P. Duke of Orlando, Gla., and neices and nephews.

The body will lie in state at the Home of his parents in League City from 10 a. m. Tuesday until 3 p. m. Wednesday. Funeral services will be conducted Wednesday at 3 p. m. from the Friends Church in League City.

Rev. W. W. Garrison, pastor, assisted by Mrs. Garrison, will officiate. Burial will be in League City Cemetery with Froberg funeral home officiating. League City Legion Post will conduct graveside services.

## Marian Fuller

Marian Virginia Bauer Fuller, born November 16, 1925, went to be with our Lord on May 27, 2020. She is preceded in death by her husband Lester Kan Fuller, Jr., and son Lester Nelson Fuller. She is survived by daughter Andrea Fuller Dickerson and two brothers Robert and Donald Bauer, her four grandchildren: Kittye Trevio (Mark), Kelly Burns, Stacy Curtis (James), and Lester Antone Fuller, and seven great grandchildren: Victoria Barta (Cody), Olivia Schlemmer (Andrew), Morgan Burns, Callan Burns, Cody Curtis, Ryan Curtis, and Haley Curtis, and finally two great-great grandchildren Tristan and Woods Barta. Marian was loved by many nieces, nephews, and many greats and great-greats of the former.

Marian was born in League City, Texas the sixth child of 8 to Charles and Lena Bauer. She graduated from the League City School in 1944. She met the love of her life, Lester Fuller, at the Silver Moon in Dickinson, Texas and that love affair would last for 67 years.

Marian worked at Camp Wallace for the Department of War, The League City Post Office, and the Galveston County Appraisal District. She found fulfillment through teaching and sharing her love for music. She was an active member of the Veterans of Foreign Wars Auxiliary, the League City Garden Club and the League City Lioness Club. Each year she and her sister, Vivian Woodard would look forward to running the lemonade booth at the League City Village Fair.

Marian was a lifelong member of the League City United Methodist Church where she would teach Sunday school, play the piano and organ, and sing in the choir. She was a lover of music and passed that love of music on to so many others. Services were held at Crowder Funeral Home, 1645 East Main Street, League City, Texas on June 6, 2020.

Note: Marian was loved by all who knew her at LCHS. She was proud of League City area and took special interest in keeping it's history alive for future generations. She was also an active member on the Fairview Cemetery Committee. Marian attended meetings regularly until health did not permit. We have such fond memories of her. What a great lady!
